A report on the findings of this session had been circulated by Rachael prior to the meeting. Rachael and Catherine spoke to a number of families at the café and we had 13 completed questionnaires. The findings were broadly in line with those from previous consultations.

#### 5. Housing needs survey results

The draft report suggests that residents would support 15-20 new houses in the parish. However there is an identified need for 14 affordable houses, so it will be challenging to meet this without a much larger development. These figures are based on the needs over the next three years – so our longer term plan needs to scale this appropriately.

The group discussed Angel House – we need to find out more about how the units there are allocated.

- Proximity to centre of the village (within 10 min walk)
- Able to support no less than 20 houses
- Protect as much agricultural land as possible
- Impact on traffic through narrow village roads
- Support from residents / alignment with consultation feedback
