#### 3. Feedback from Parish Council on review of AECOM report

The PC reviewed all the sites in the AECOM report, but then ran out of time to discuss the subsequent report from Place Studio. This will be discussed on the 9<sup>th</sup> November and the outcome reported to the steering group following that.

### 4. Evidence Gathering

#### a. Heritage audit walk around and progress - Rachel

Yet to happen. Due to lockdown this may be challenging in the coming weeks.

#### b. Call for heritage sites-collection

Call for potential heritage features to go out in The Hoot, with people asked to drop off suggestions in the Church porch or village shop. The Parish Council agreed to a £50 donation to The Hoot to fund the inclusion of this call for heritage sites.

In the run up to this call for heritage sites we have made a series of posts on Facebook highlighting a few potential ones, in order to raise awareness of this topic.

Catherine: ask if we can put a box in the shop

#### c. Landscape report- Mel
